 - iii) Three Years Diploma (Telecommunication / Electronics / Radio / Computer/Electrical / IT/ Instrumentation) or
 - iv) B.Sc. (Electronics)/B.Sc.(Computer Science) or
 - v) B.Sc. with Physics and Math.
